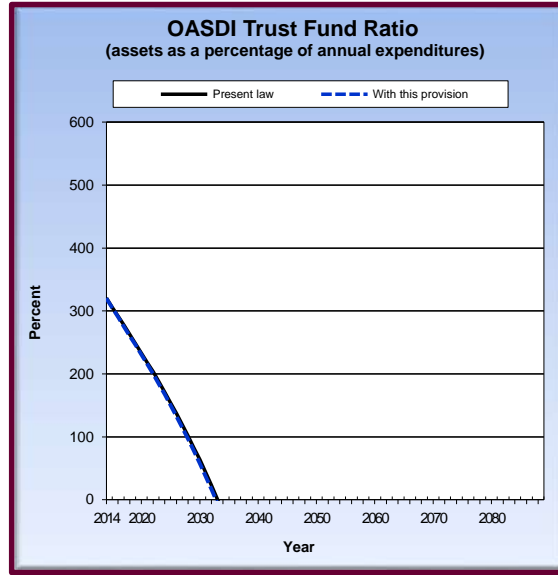
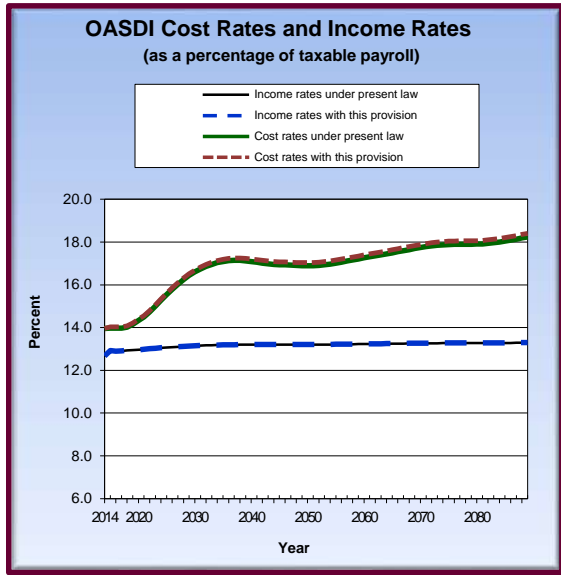


Summary Measures and Graphs
Category of Change: Level of Monthly Benefits

Proposed Provision: Provide a 5 percent increase to the monthly benefit amount (MBA) of any beneficiary who is 85 or older at the beginning of 2015 or who reaches their 85th birthday after the beginning of 2015.
