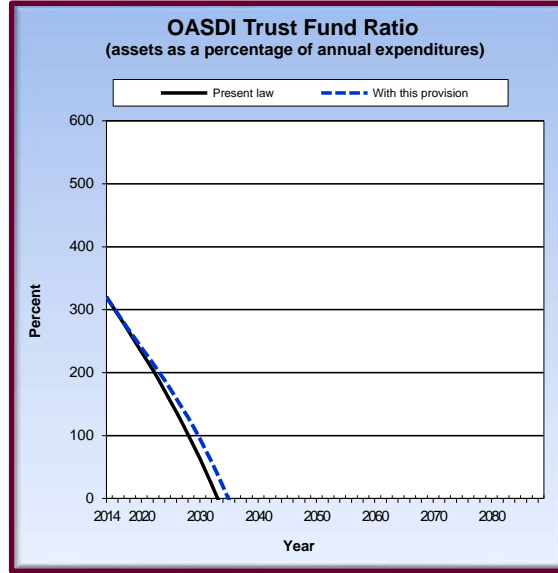
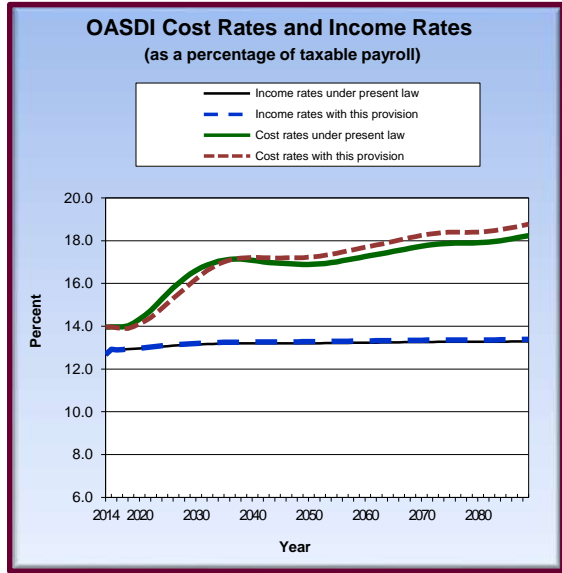


Summary Measures and Graphs

Category of Change: Retirement Age

Proposed Provision: Increase the earliest eligibility age (EEA) by two months per year for those age 62 starting in 2016 and ending in 2033 (EEA reaches 65 for those age 62 in 2033).
